## MAY: PRINCIPLES OF PROFESSIONAL ETHICS




**May 13, 2024: In Person 11:30am – 1:00pm Virtual Noon-1pm**

According to the U.S. Bureau of Labor Statistics, more than 400 work-related deaths have been caused by environmental heat exposure since 2011. The new ANSI/ASSP A10.50 is the first national consensus standard to address heat stress management in construction and demolition operations. It explains how to help prevent heat illnesses and provides an approach any organization can use to help workers acclimate to working in high-heat conditions. It also identifies relevant engineering and administrative controls to help control the hazards of heat.

- Identify the foundational elements of a work-related heat stress management program for both outdoor and indoor work environments

# SAFETY MINUTE

## OSHA HAZCOMM STANDARD UPDATE

On May 20, 2024 OSHA issued a final rule updating the Hazard Communication Standard (HCS) to align with the seventh revision of the United Nations' Globally Harmonized System of Classification and Labelling of Chemicals (GHS). The final rule takes effect on July 19, 2024. The updates are intended to increase worker safety and awareness when working with chemicals. Below are a few highlights of the rule and changes to keep on your radar.

- Revised classification criteria for chemical products such as aerosols, desensitized explosives and flammable gases.
- New Chemicals Under Pressure hazard category under aerosols.
- Revised provisions for labels, including provisions addressing the labeling of small containers, 100 mL or less in volume, and very small containers, 3 ml or less.
- Additional criteria to consider when classifying a chemical, and its associated effects to include in Section 2 of the product safety data sheet (SDS).
- Updates to information requirements for SDSs, including addition of "particle characteristics" for solid products in Section 9 of SDS.
- New trade secret guidelines relating to how chemical manufacturers can choose to use concentration ranges of chemicals.
