It's that time of year again! On Tuesday, Sept. 17th at the National Safety Council Safety Congress & Expo, Scott Ketcham, Director of the directorate of enforcement programs for OSHA, announced the 10 most frequently cited workplace safety standards for fiscal year 2024:

- Fall Protection General Requirements (1926.501) 6,307 violations
- 2. Hazard Communication (1910.1200) 2,888 violations
- 3. Ladders (1926.1053) 2,573 violations
- 4. Respiratory Protection (1910.134) 2,859 violations
- 5. Lockout/Tagout (1910.147) 2,443 violations
- 6. Powered Industrial Trucks (1910.178) 2,248 violations
- 7. Fall Protection Training Requirements (1926.503) 2,050 violations
- 8. Scaffolding (1926.451) 1,873 violations
- 9. Personal Protective and Lifesaving Equipment—Eye and Face Protection (1926.102) 1,814 violations
- 10. Machine Guarding (1910.212) 1,541 violations


MONTHLY MEETING

SAFETY MINUTE

INDUSTRIAL HYGIENE AND DATA ANALYTICS

In the world of data analytics information is mined from various sources and gathered into meticulous piles to be organized, categorized, and synthesized into digestible formats for target audiences. Industrial hygiene (IH) investigations are themselves a goldmine of raw data waiting to be digested. Many workplaces have years of past IH exposure monitoring data that can be used to make informed exposure assessment decisions, provided that statistical tools are utilized properly.

Many statistical analysis tools exist free of charge with training readily accessible through industry groups like the American Industrial Hygiene Association (AIHA). These tools utilize Bayesian statistical techniques to analyze trends in exposure monitoring data. Using this approach, exposure categories are assigned to the sample set based on the exposure results for each relevant Similar Exposure Group (SEG) using a defined decision statistic (e.g. the 95th percentile). This enables the Industrial Hygienist to determine the probability that the true 95th percentile of the exposure results would fall within one of the AIHA Exposure Rating Categories, which range from 0 (<1% of the Occupational Exposure Limit) to 4 (>100% of the OEL), where 0 represents a negligible exposure and 4 represents a poorly controlled exposure. A confidence rating is also assigned to these results.

Risk decision

▶ Criterion defining overexposure:

95th percentile ≥ OEL

 Uncertainty management: based on the Bayesian model, the probability that this criterion is met (overexposure risk) is:


87.1%

 Uncertainty management: The probability of overexposure (overexposure risk) should be:

< 30%

▶ As a consequence, the current situation is declared:

Poorly controlled

Looking at industrial hygiene data in this way can tell us about several things in a short amount of time. By looking at the distribution we can see if the similar exposure groups (SEGs) we have chosen have been selected properly. We can tell if the sampling rates are occurring at the right frequency and if the sample sizes are adequate.

While Bayesian tools are great for statistical analysis, there are ways to take the data a step further. This is also true for any additional information that may be paired with quantitative results. Risk rankings, qualitative analysis, prevention through design, and audit findings to name a few. The numeric output of any of these assessments can be placed into a visual data analytics tool to help drive decision making and impact stakeholders.

It is important to ensure that your data is sound, and your metrics are consistent across multiple collection events. The adage "garbage in equals garbage out" applies here and comes up very often in topical conversations. If establishing a new program align on terms, units of measurement, and other similar parameters at the start. For seasoned programs it is not too late to create a reference or dictionary. Once you have alignment connections can be established to form a total picture of true exposure risks and drive informed decision making. – Amanda Sandidge Engstrom, CIH, CSP, Mountain Valley Secretary

OSHA LEP

On July 18, 2024, OSHA issued a Local Emphasis Program (LEP) for Cannabis Industries in the Denver region. The goal of the new directive is to reduce the incidence of serious health and physical injury or death from hazards associated with cannabis processing, growing, cultivating and product manufacturing facilities. As a part of the announcement, OSHA shared the most common citations issued based on 44 inspections that occurred during the last 7 years at cannabis production facilities.

- Hazard Communication (1910.1200)29 (66%)
- Respiratory Protection (1910.134) 18 (41%)
- Personal Protective Equipment (Excl. RP) 9 (20%)
- Flammable Liquids (1910.106) 8 (18%)
- Electrical Hazards/Classified Locations (1910.307)7 (16%)
- Machine Guarding/LOTO (1910.212; 1910.147)
 6 (14%)
- Fall Protection & Walking/ Working Surfaces (1910.28; 1910.22)4 (9%)

The LEP, in effect through July 18, 2029, wanted to bring attention to "[a]ctivities such as extraction and production of concentrates involve the use of flammable liquids and have resulted in serious injuries to employees from burns and explosions. Other hazards such as electrical issues, exposure to hazardous chemicals and unguarded machinery are also prevalent."
